Manager's Review April 2019

Well, we're off with a roar and not a dull or quiet roar. Of course if you have been in the active roofing zones or in your home during re-roofing you know this.

Special Meeting of Owners: As you all know we typically only do one general membership meeting a year which is the annual meeting. As well as the March 12th membership meeting went, great venue, great snacks, great presentation, great Q & A session and great attendance maybe we ought to get together more often. Don't tell Bonita I suggested that as it is a tremendous amount of work for her but she sure is good at it.

We truly appreciate the turn-out by owners and non-owner residents. In advance of the re-roofing presentation the members discussed and asked questions regarding the initiative to reduce the number of board members from nine (9) to seven (7) beginning 2020. The vote to go to seven (7) board members was overwhelming with over ¾ of those voting in favor. Thanks again to all who attended.

Re-Roofing: As of this writing we are one week into the estimated 10-12 week project. The roofers make great progress each day and are running a very tight job site.

We expect various inconveniences to occur with a project of this scope but greatly appreciate everyone's patience and cooperation. Most of the roadways and routes in our community have another way

around. If at all possible, please take the route that avoids the re-roofing area. When it comes time for some of the tight dead ends i.e. Adriel Way, Adriel Circle, Heber Dr., Elim Ct., etc. access and parking in these areas may be limited or restricted during re-roofing.

Other Projects

Exterior Building Repair: Jake Brown, Brown Dog Construction continues building repairs and improvements to Building-41. In addition to repairs the two owners with decks determined to have Jake replace their wooden deck railings with new metal and composite deck railings. This improvement has become more and more popular with owners realizing several benefits.

First, the opportunities for owners to upgrade or change the exterior appearance of their home is limited. The replacement of deck and courtyard railings (as numerous owners have done) is probably the most impressionable exterior upgrade a home- owner can implement. Not only does this update the exterior appearance of your home but most likely increases the value. The metal deck railings also enhance views from decks as the railing pickets and railings themselves are narrower or a smaller profile minimizing view obstruction. would like more information regarding this up upgrade for your home, please contact the office.

Bonita once again pulled off another smoothly-run meeting. The "Special Meeting of Homeowners" process prior to and at the meeting is very similar to the annual meeting. Bonita also emailed the meeting minutes, zone map and Premier flyers to homeowners who were unable to attend. Thank you Bonita for another well organized presentation.

Golf Course: As the season begins, we remind golfers that they must yield to all golf course maintenance operations. Adriel Hills does not have a dedicated golf course crew starting at 4:00 a.m. daily as for-profit and club courses have. Golf

course maintenance must be done during the course of the day. The Adriel Hills Rules and Regulations clearly indicate that all golfers must yield to maintenance operations; this is of course for the safety of the maintenance crew. Those choosing to endanger the crew are endangering their privilege to golf at Adriel Hills.

Recycling: Recycling is great; however, please be sure you are following Larimer County recycling regulations. Attached is an excerpt from Larimer County website with guidelines to follow. Please do not throw plastic bags into the recycle totes. Please throw all plastic bags away.

Pet Cleanup: Per Rules and Regulations all residents must clean up after their pets. If you notice that someone is not cleaning up after their pet, please put in writing for the Adriel Hills office the date, time, dog owner and location so a violation notice can be sent.



What can be recycled curbside

Please view the photo below to see what can and cannot be recycled curbside. (Contact your trash and recycling hauler for specific requirements.) You can recycle cardboard, glass bottles and jars, metal cans, plastic bottles/jars/jugs and tubs, and paper/paperboard, including cartons.









Recycle at Home

In Larimer County, curbside recycling is available for most households either through their municipality or a local hauler. With some haulers, it is advantageous to recycle more items and reduce the size of your trash cart, as pricing is based on cart size. If you live in an area where curbside recycling is not available, you may use the <u>recycling drop-off</u> bins at the landfill and residential convenience centers.

Single stream recycling is the method used for recycling collection in Larimer County. This means that all recyclables can be collected in the same container to be transported to the recycling center. Recycling pickup typically occurs once every two weeks.

It isn't rocket science, but it can be confusing

- Just because it's plastic or paper doesn't mean it's recyclable!
- Ignore the chasing arrows symbol; that doesn't necessarily mean it's recyclable.
- Recycle only plastic containers, and only if they're one of four shapes: bottles, jars, jugs and tubs.
- Most paper can be recycled but the main exceptions are as follows: do not recycle paper towels, paper plates and paper cups.
- All paperboard boxes can be recycled except for boxes from the freezer.
- Containers made of mixed materials should not be recycled (such as: Pringles containers).

How to recycle properly

- Ensure containers are clean, empty and dry.
- Flatten cardboard boxes.
- It's okay to leave labels and lids on.
- It's okay to recycle paper products with tape, rubber bands and staples, and envelopes with windows.
- Use a spatula or spoon to remove excess product from containers such as peanut butter and dressing.
- Do not recycle plastic bags in your recycle cart!

How to recycle items not accepted curbside


What happens to my recyclables?

Recyclables are collected and transported to the Recycle Center at the landfill. After they are unloaded inside the center, fiber (cardboard and paper) is separated with an OCC Screen, baled and shipped directly to market. Remaining recyclables are transported to a Materials Recovery Facility (MRF) where they are separated and prepared for marketing to a manufacturer that uses recycled content for new products.

At the MRF, various methods separate the mixed recycling based on material type. Screens isolate fiber from containers, air jets sort heavier and lighter plastics, optical sensors separate plastics by polymer type or color, and magnets and eddy currents (powerful magnetic fields) separate steel from aluminum.
