MANAGER'S REVIEW

COVID-19/Amenity Use: Prior to the October 20th Board of Directors' meeting, the board received several notes from residents requesting opening of the sauna, hot tub and changing room. A plan to do so was provided to the board and approved effective Monday November 2, 2020 with the understanding things could change due to the uncertainty related to COVID-19. However, due to the Larimer County's risk status continuing to increase well into the high range, the amenity use expansion has been placed on pause. The exception is that the changing room only, is now available for a maximum of two people at a time. All other amenity provisions that have been in place will remain and are as follows:

- Pool open 8:00 am to 8:00 pm Wednesday-Sunday
- Maximum eight (8) people allowed in the indoor pool area at one time with a two (2) hour limit
- Changing room (only) open w/maximum of two (2) people
- No guests allowed
- Library open Tuesdays & Thursdays 9:30-4
- Call and schedule appointment with Bonita for HOA needs, etc.

PLEASE NOTE; THE CLUBHOUSE WILL BE CLOSED IN ITS ENTIRETY ON THANKSGIVING DAY – THURSDAY - NOVEMBER 26TH, CHRISTMAS DAY -

FRIDAY - DECEMBER 25TH AND NEW YEAR'S DAY FRIDAY - JANUARY 1ST. THIS INCLUDES THE POOL, MAIL AND LIBRARY.

Annual Meeting: Due to COVID-19, a traditional type annual meeting cannot be held. The Board of Directors gave consideration to a teleconference type annual meeting; however, for groups as large as our typical annual meeting (sixty plus), they become unwieldy and not all members have access capability. The board determined an annual report package will be provided to all members including annual meeting reports and a ballot/proxy for the Board of Directors election.

This package will go out the week of November 16th via email or pigeon holes. BALLOTS MUST BE RETURNED VIA MAIL, EMAIL OR DROP BOXES BY NOON ON TUESDAY, DECEMBER 8TH; THIS YEAR'S PUBLISHED ANNUAL MEETING DATE.
